

**\*UPDATED NOTICE OF ROAD CONSTRUCTION IN SHERINGHAM (4/27/18)**

**\*UPDATED TO ALLOW MORE PARKING- 4 phases now**

**\*\*\*Please check MAP on back\*\*\***

Meadow Pointe III has a contract with Whitaker Contracting Corporation to treat subdivision streets in the Meadow Pointe III Community with a pavement preservation product, HA5, which is intended to extend the life of the streets decades past their design life and save residents road re-surfacing costs.

**Weather may cause a delay to the project. If there is a rain delay, those phases will be rescheduled to occur at the end of the project so that all other phases will remain on schedule. A paper notification similar to this notice will be hand delivered to the neighborhoods that are being rescheduled with the new date. The updated schedule will also be posted on the CDD website at meadowpointe3.org.**

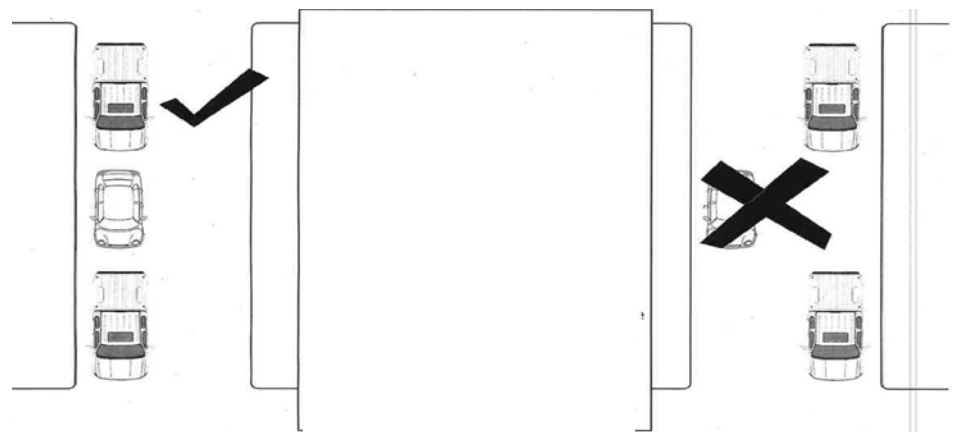
To obtain the full benefit of the treatment to maximize the financial savings, the CDD asks residents to do the following:

1. **MAP/SCHEDULE:** Please review the Map on the back page; at that time, please note when the work will be done in front of your home. Your driveway will be affected for a 24-hour period beginning 7am the day of your scheduled closure to 7am the next morning. You will not have access to your driveway during this 24-hour closure.
2. **ALL OUTSIDE IRRIGATION MUST BE TURNED OFF.** So that the contractor can apply the treatment in a dry condition, please make sure your irrigation system is turned off between 6:00 pm the day before the work is scheduled to be done in front of your home and midnight of the work day.

**3. PARKING:**

- a. **DRIVEWAY ACCESS:** Between 7:00 am on the work day in front of your home to 7:00 am the following day while the treatment is drying and curing (24 hours), you will not have access to your driveway. Any damage done to private property due to traveling over a treated street earlier than requested will not be repaired by the contractor or the CDD, and any damage done to the pavement treatment as a result of not complying with this request will be documented for possible legal action.

- b. **WHERE TO PARK:** Park in your neighborhood on the street in a phase that is not scheduled for that day. Only park on one side of the road per the image to the right to allow emergency access.



4. **SERVICE VENDORS:** Please ask any service vendors (landscapers, special deliveries, construction, etc.) to avoid working on the days that the treatment is planned to be done in your community.
5. **GARBAGE & MAIL:** The contractor is working to notify garbage collection and mail delivery services of the work plan.
6. **SPECIAL NEEDS:** If you have any additional special needs that need to be accommodated, please contact Amy Blaida@ 813-468-4576. There will be a handicap accessible van or golf cart available.
